## INVESTMENT OBJECTIVE & POLICY

Methodical BCI Bond Fund aims to generate returns above the JSE All Bond Index ("ALBI") over time, utilising active bond management combined with strategies which aim to reduce risk. This portfolio will typically have longer duration bond exposure in line with the ALBI, resulting in the potential for some capital volatility over the shorter term. The portfolio is managed with the aim to minimize the probability of capital losses over one-year rolling periods.

In order to achieve this objective, the investments normally to be included in the portfolio will comprise a combination of assets in liquid form and a combination of bonds and interest bearing securities, including loan stock, debentures, debenture bonds, money market instruments, corporate debt and non-equity securities. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act, and the Regulations thereto, as amended from time to time, in order to achieve the portfolio's investment objective. The manager may also include forward currency, interest rate and exchange rate swap transactions for efficient portfolio management purposes.

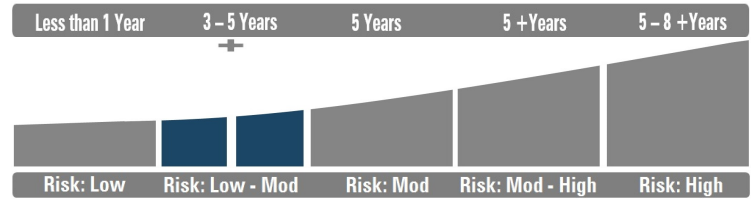

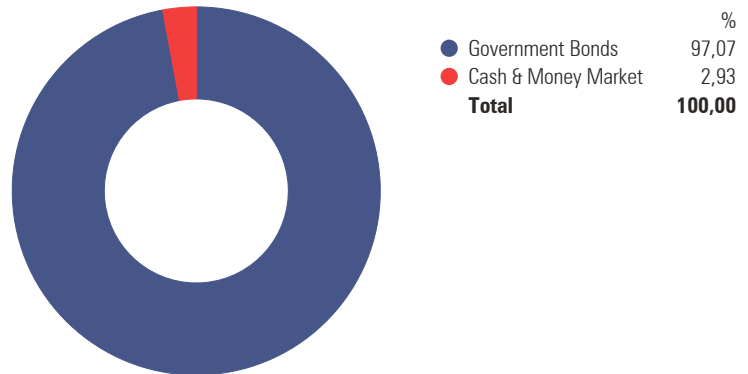
## RISK PROFILE RANGE
